# Deeds and Records

The Manor of Bradnop was formerly a possession of Abbey Hulton. It was acquired by the Aston family. Subsequently, in 1770, John Sneyd of Bishton purchased the Manor with 2,000 acres of land from the descendants of the Aston family namely from Sir Walter Blount who had married Mary Aston and Sir Thomas Clifford who had married Barbara Aston.
